REGISTRATION INSTRUCTIONS

Any boat with a motor or sail, all snowmobiles and off-highway vehicles [includes motorcycles (dirt bikes), three wheelers, four wheelers and dune buggies, does not apply to scooters, mini bikes or golf carts], operated in Colorado for recreational purposes must be registered with Colorado Parks and Wildlife. In order to register a vessel/vehicle in Colorado please follow these instructions:

A. Complete the Registration Application

1. Please print or type using pen or ink. Please verify that all information is correct, complete and legible.
2. Complete the "Owner Information" section, and sign the certification statement at the bottom of the form. In order to register the vessel/vehicle in more than one name the application must reflect the following:
 - a. The names of **ALL** legal owners.
 - b. Each owner's respective birth date.
 - c. The signatures of **ALL** owners at the bottom of the form. (Certification Statement.)
3. Please physically inspect your vessel/vehicle for an Identification Number (Hull I.D. number for boats and Vehicle I.D. number for snowmobiles and off-highway vehicles). The HIN/VIN is a serial number assigned to the vessel/vehicle by the manufacturer. If the vessel/vehicle has no number please call our office for assistance, or take the vessel/vehicle to a state park or state park office for a physical inspection by an officer.
4. Complete the appropriate Registration Section and check (✓) the appropriate fee box at the top of the page.
5. You must include one acceptable proof of ownership document with your registration form. Acceptable proof of ownership documents include:
 - Bill of sale that includes both the seller and buyer's printed names and signatures, the vessel/vehicle identification number, the vessel/vehicle make, model and year (if known), and the date of the sale. A bill of sale template can be found on our website
 - Previous registration certificate issued by a governmental entity that lists the applicant as registered owner
 - Manufacturer's Certificate of Origin (MCO)/Manufacturer Statement of Origin (MSO)
 - Certificate of Title
 - Any court issued document proving ownership
 - A collection of personal property by affidavit form pursuant to 15-12-1201, C.R.S.
 - A physical inspection form completed by a CPW agent

B. Submit the proper fee — See fee schedule at the top of the form.

1. Make checks and money orders payable to Colorado Parks and Wildlife or fill out the credit card information at the bottom of the form.
2. Colorado Parks and Wildlife is **NOT** responsible for cash sent through the mail, please do **NOT** send cash.
3. Pursuant to 33-1-112.5 CRS, \$.25 has been added to the registration fee for the Search and Rescue surcharge.
4. Pursuant to C.R.S. Section 33-10.5-104.5, all motorboats and sailboats operating on Colorado waters must purchase an Aquatic Nuisance Species (ANS) stamp. A person who pays for the ANS stamp must retain the stamp receipt on his or her person or on the motorboat or sailboat when operating the vessel. The stamp for motorboats and sailboats registered in Colorado is \$25 and has been added into the registration fee on this form. Funding contributes to the detection, prevention and management of ANS in the state. Thank you for your contribution.

D. All transactions take a **minimum** of 2 to 4 weeks to process. On a Transfer or Renewal transaction, if the registration number provided cannot be verified by Colorado Parks and Wildlife records or a previous Colorado Registration Certificate, a new registration number will be assigned to that vessel/vehicle.

E. Registrations are non-transferable and non-refundable.
