

AIRCRAFT BILL OF SALE

- V. **Inspection Period.** The Buyer shall have the right to inspect the Aircraft for up to ____ days before the transfer of sale. The inspection shall be at the expense of the Buyer. It is understood that after the transfer of possession the Aircraft is being sold with no warranties by the Seller and shall be held harmless for any defects found after the fact.
- VI. **Inability to Perform.** If the Buyer is not able to make the payment for the purchase of the Aircraft, this agreement shall be considered void and any non-refundable deposits shall be kept by the Seller. If the Seller is not able to transfer the title to the Aircraft due to damage beyond repair or seizure the agreement should become void with all deposits being refunded to the Buyer along with reimbursement for any due diligence costs.
- VII. **Taxes.** Buyer agrees to pay any and all taxes imposed by local, State and Federal governments for the transaction of the Aircraft.
- VIII. **Assignment.** This agreement may not be assigned to anyone without the written permission of the Buyer and Seller.
- IX. **Notice of Parties.** The parties shall recognize each other's mailing addresses for any notices.
- X. **Laws.** The agreement shall be considered legal and binding pursuant to the laws in the State of _____.

- XI. **Waiver.** If the Buyer or Seller do not enforce any section of this document against the other party it shall not be considered as a waiver to the excuse them from future performance of that section or any other.
- XII. **Severability.** The invalidity of any section of this agreement does not affect the validity of the remaining sections thereof.
