

STATE OF GEORGIA VESSEL REGISTRATION APPLICATION

Georgia Law O.C.G.A. 52-7-4 requires that ALL mechanically propelled vessels AND sailboats over twelve feet in length that are used on waters of this state be registered. Registration is NOT required for: 1. Sailboats less than 12 ft. in length with no mechanical propulsion; 2. Canoes, kayaks, rowboats and rubber rafts that have no mechanical propulsion; and 3. Boats operated exclusively on private ponds or lakes.

- > Online: Go to www.georgiawildlife.com and select Vessel Registration. Must use credit card for payment.
- ➤ Call 1-800-366-2661. Must use credit card for payment.
- ➤ Mail in the completed VESSEL REGISTRATION APPLICATION and payment.
 - 1. Complete all spaces on the VESSEL REGISTRATION APPLICATION.
 - 2. Write the payment amount in the box provided at the bottom of the Fee Table.
 - 3. Do not send cash. Make checks and money orders payable to GEORGIA DNR.
 - 4. BE SURE TO SIGN YOUR REGISTRATION APPLICATION.
 - 5. Mail the application with payment <u>and all required documentation</u> to this address. **If required documentation cannot be obtained, complete the attestation below.**

O.C.G.A \$16-10-20: "A person who knowingly and willfully makes a false, fictitious or fraudulent statement... in any manner within the jurisdiction of any department or agency of state government...shall, upon conviction thereof, be punished by a fine of not more than \$1,000 or by imprisonment for not less than five years, or both."

TEMPORARY CERTIFICATE / AUTHORIZATION NUMBER valid for 60 days only in Georgia, and may be used only if the vessel has a valid Hull Identification Number (HIN) or is exempt from HIN requirements because it is a 1972 or older vessel. IMPORTANT: To Use Temporary Registration, applicant must KEEP A COPY of completed application & a COPY OF PAYMENT while the boat is being operated (if mailed), have a copy of the online renewal receipt (if done online), or have a temporary authorization # in possession (telephone).
