3. Order Regarding Removal of Case from the Public Index (if requested)

- The requested removal from the public index is **DENIED** because the court finds that the public's interest in disclosure outweighs the petitioner's concerns over the personal or sensitive nature of the case or that disclosure of the name is not likely to result in substantial harm to the party or members of the party's household.
- The requested removal from the public index under **Admin. Rule 40(b)** is **GRANTED**. The clerk shall substitute "Not Published" for the party's name on the public index.
- The requested removal from the public index under **Admin. Rule 40(c)** is **GRANTED**. The clerk shall substitute "Not Published" for the party's name on the public index for five years. After five years, the party's name will appear on the public index unless the presiding judge orders the name protected for a longer time upon another request by the party showing that publication of the name is likely to result in substantial physical harm to the party or members of the party's household.
