- Inspection. Manager shall perform an inspection on property to check for any major structural or mechanical issues. The inspection will ensure the home is properly cared for and any issues found can be addressed in a timely manner. A fee of \$ will be charged per Annual inspection plus the cost of the AC filter (if needed). 13. Term of Agreement. This Agreement shall be effective as of the (start date) and (end date). Upon expiration of the above initial term, this shall expire on the Agreement shall automatically be renewed and extended for a like period of time unless terminated in writing by either party by providing written notice 14 days prior to the date for such renewal. This Agreement may also be terminated by either parties at any time. Upon termination Owner shall pay to Manager any fees, commissions and expenses due Manager under terms of this Agreement, which are owing to Manager. In the event of the premises not renting within a 90-day period of entering into this agreement, or of a vacancy continuing for a period of longer than 90 days, Owner reserves the right to declare this agreement void. 14. Successors and Assigns. This Agreement shall be binding upon and inure to the benefit of the successors and assigns of Manager and the heirs, administrators, successors, and assigns of the Owner. Notwithstanding the preceding sentence, Manager shall not assign its interest under this Agreement except in connection with the sale of all or substantially all of the assets of its business. In the event of such sale, Manger shall be released from all liability under this Agreement upon the express assumption of such liability by its assignee.
